- All artwork must be handcrafted in the US by the artist.
- ARTour is a juried show. Artists who participated in ARTour in 2014 or 2015 do not need to be juried.
- All artwork must be of professional quality and be consistent with the work initially submitted for jurying.
- Each artist is responsible for collecting and submitting sales tax and must provide a valid California Seller's Permit number with their application
- North Tahoe Arts does not insure artwork in the gallery or on location in Tahoe City, nor does it insure booth displays. Artists are encouraged to carry their own insurance.
- Education is a mandatory component of ARTour. Artists must be prepared to discuss, demonstrate and/or explain their techniques, processes, materials, and equipment used. This may be a hands-on demo, a brief presentation or a combination. Demos and presentations should be 10 – 15 minutes and will be repeated twice each day. NTA will provide volunteers to watch your booth while you are occupied with the demo.
- Artists grant permission to North Tahoe Arts (NTA) to use their name, likeness and/or voice for all publicity purposes and in any media format, relating to promoting and building awareness of ARTour. Media formats include, but are not limited to: newspapers, magazines, television, radio, film, and social media.
- Goods and services other than those relating to your artwork and unrelated manufactured or commercial goods MAY NOT be exhibited for sale.
- Work of non-participating artists, family, friends and/or others MAY NOT be offered for sale.
